Travel Team: Travel team try-out deadline to be determined by league commissioner. Travel teams and tournaments are chosen from kids that indicate interest on this form, willing to dedicate more time to the game and having the physical ability to do so. There IS an additional fee to participate on these teams.

COMPLAINT PROCEDURE: The following complaint procedure will be strictly adhered to.

- 1) Any complaint, questions or problems are to be made first to the coach of the team in which that child is a member.
- 2) If the problem or question is not satisfactorily taken care of and the parent desires to pursue it further then a written outline of the problem is provided by the complaining party to the Commissioner of the league in which the child is participating.
- 3) If the problem is not solved at this level, then a written summary is submitted by the commissioner listing the pertinent facts, attaching the original written complaint and is then forwarded by the commissioner to the Over All Commissioner. If not solved by the Over All Commissioner, it will then be taken by the overall commissioner to the "Executive Committee".
- 4) The "Executive Committee" (made up of four officers) issues either a written opinion to the complaining party with copies to all parties involved or asks for an informal hearing in which all parties are given an opportunity to be heard, with a written opinion issued thereafter.
- 5) The "Executive Committee's" decision is final.
